2. The bid bond submitted by bidder whose offers have not succeeded, or that have been rejected, will be returned within 7 days from the date of rejection of the tender.
3. The bid bond deposit submitted by the buyer is included in the price.
4. The tender deposit is not refundable if the successful bidder, who won the public tender, fails to conclude the sale agreement.

**TENDER DOCUMENTS:**

The offers should include the following information:

- The bidder's declaration that he/she is conversant with the legal and factual state of the vehicle, or is willing to incur all and any liability for the consequences arising from the failure to inspect the vehicle.

The tender committee will reject the offer if:

The tender committee shall immediately notify the tenderer of the rejection of the tender.

#### **OTHER INFORMATION:**
